Eligibility

The applicant must be a student (or have applied for admission) at the University of Washington.

How to Apply

Applications are available through the web site or address below. Applications must be received three months prior to the quarter for which a scholarship is requested.

Who Will Award the Scholarship?

A panel of three WMGF Board members will review all applications and make recommendations to the board for final decisions.

Three criteria (in no particular order) will be used to determine scholarship recipients:

1. Financial need
2. Academic standing and potential
3. Gymnastics ability

These criteria may be considered equally in selecting recipients.

What is the WMGF?

The WMGF is an organization whose sole purpose is to financially support the University of Washington Men's Gymnastics Club. Membership is open to anyone with interest in helping.

Funds

The Dr. Eric Hughes Scholarship Fund is an endowment set aside for the sole purpose of granting scholarships to worthy applicants.

Letters of Recommendation

Three letters of recommendation are required in addition to the application.

Letters may be from a coach, teacher, minister, or employer but not from a relative, and must be received three months prior to an award.
